Reopening K-12 Schools at RSU 18

Considerations and Recommendations that support the reopening of our schools

The Maine Department of Education has developed guidance to support districts and communities in determining their plans and strategies for reopening schools.

This approach is built upon the guidance and recommendations of health officials; it is strongly aligned to the reopening guidelines that have been provided by our state and federal leaders; and it's designed to help districts prioritize the health and safety of students and teachers as they open school buildings and deliver instruction for the 2021 - 2022 school year.


Regional School Unit No. 18 has developed a systemic approach to reopening our schools based on the guidance from local health officials, the Maine Center for Disease Control (MCDC), the Maine Department of Education, the American Academy of Pediatrics, our professional staff who served on collaborative committees to identify a safe approach to opening schools, and parent feedback from surveys and district-wide meetings.

District/School Considerations:

- Provide hand sanitizer for students and bus drivers
- Follow any state mandates requiring face covering to be worn on buses.
- Limit field trips (to areas of limited/low transmission)
- Inspect buses prior to students returning and as part of a regular rotation
- Clean frequently touched surfaces on the bus
- Air out buses when not in use

District/School Considerations:

- Provide hand sanitizer for students and bus drivers
- Follow any state mandates requiring face covering to be worn on buses.
- Ask students (parents) to use a screening tool for symptoms of illness prior to boarding the bus
- Utilize spaced seating (to the extent practicable)
- Consider eliminating field trips
- Clean frequently touched surfaces on the bus

District/School Considerations:

Adhere to CDC and MDOE practices for transportation

Entering Schools



District/School Considerations:

- Provide hand sanitizer for students and staff
- Educate staff and students on strategies to curb the spread of COVID-19.
- Establish a protocol for students/staff who feel ill/experience symptoms when they come to school
- Isolate and send home if temperature is over 100.4°F when determined appropriate after consulting with the school nurse or other medical professional
- Establish a protocol for visitors

District/School Considerations:

- Educate staff and students on strategies to curb the spread of COVID-19.
- Ask students (parents) to use a screening tool for symptoms of illness prior to entering school
- Isolate and send home if temperature is over 100.4°F when determined appropriate after consulting with the school nurse or other medical professional
- Consider safety and privacy concerns (confidentiality should be maintained)
- Establish a protocol for visitors: Restrict nonessential visitors in the building, calling front office before entering, screening any approved visitors, etc.
- Establish a protocol for student pick/drop up: staggered entry and release (by grade, class, or bus numbers), marked spacing for pickup

District/School Considerations:

- Virtual tools and platforms will be used by district staff to deliver instruction.
- Exceptions for students to be in a school building will only be made by district administrators.

Supporting Teaching and Learning



District/School Considerations:

- Provide hand sanitizer for students and staff
- Conduct cleaning of classrooms and high touch surfaces each day
- Develop a district assessment calendar
- Utilize either Seesaw (pre k grade 2) or Google Classroom (grades 3 -12) to facilitate instruction
- Support the development of grade level academic topics
- Provide additional instructional supports to:
 - o students at-risk of not graduating on time
 - o students with disabilities
 - o students who struggled in the prior distance/remote learning environment
- Implement strategies and interventions to reengage students who developed this need during the pandemic

District/School Considerations:

- Utilize either Seesaw (pre k grade 2) or Google Classroom (grades 3 -12) to facilitate instruction
- Balance class numbers as much as possible remove unused desks and furniture in classrooms; maximize social distancing (to the extent practicable)
- Limit physical interaction through partner or group work
- Establish appropriate distance between the teacher's desk/board and students' desks
- Identify and utilize large spaces (i.e. gymnasiums, auditoriums, outside spaces – as weather permits) for social distancing
- Implement strategies and interventions to re-engage students who developed this need during the pandemic

District/School Considerations:

- Implement a Distance Learning Plan
- Utilize either Seesaw (pre k grade
 2) or Google Classroom (grades 3 12) to facilitate remote learning
- Provide technology tools and support to families

Communication

District/School Considerations:

Provide consistent forms of communication for staff and families on important issues Changes happening in the school

- Mandates
- Closures
- Educational issues

Provide the RSU 18 community with opportunities to provide feedback into the decision-making process

- What changes need to be made to our reopening of school plan?
- What do our students / staff / school community need to do to improve educational opportunities as a result of the pandemic?
- How can we utilize funding sources to re-engage students and improve school safety and mitigate transmission of this and other viruses?

When a Child, Staff Member, or Visitor Becomes Sick at School



District/School Considerations:

- Work with school administrators, school nurses, and other healthcare providers to identify a process to separate anyone who exhibits COVID-like symptoms.
- Notify local health officials of a possible case.
- Inform those who have had close contact to a person diagnosed with COVID-19 to follow CDC guidance if symptoms develop

Any student or staff member who is diagnosed by a physician to have tested positive for COVID-19 will be required to follow the current CDC guidelines for isolation.
