

# Reopening K-12 Schools at RSU 18

## Considerations and Recommendations that support the reopening of our schools

The Maine Department of Education has developed guidance to support districts and communities in determining their plans and strategies for reopening schools.

This approach is built upon the guidance and recommendations of health officials; it is strongly aligned to the reopening guidelines that have been provided by our state and federal leaders; and it's designed to help districts prioritize the health and safety of students and teachers. ~~as they open school buildings and deliver instruction for the 2020-2021~~ 2021-2022 school year.

*Regional School Unit No. 18 has developed a systemic approach to reopening our schools based on the guidance from local health officials, the Maine Center for Disease Control (MCDC), the Maine Department of Education, the American Academy of Pediatrics, our professional staff who served on collaborative committees to identify a safe approach to opening schools, and parent feedback from surveys and district-wide parent meetings.*

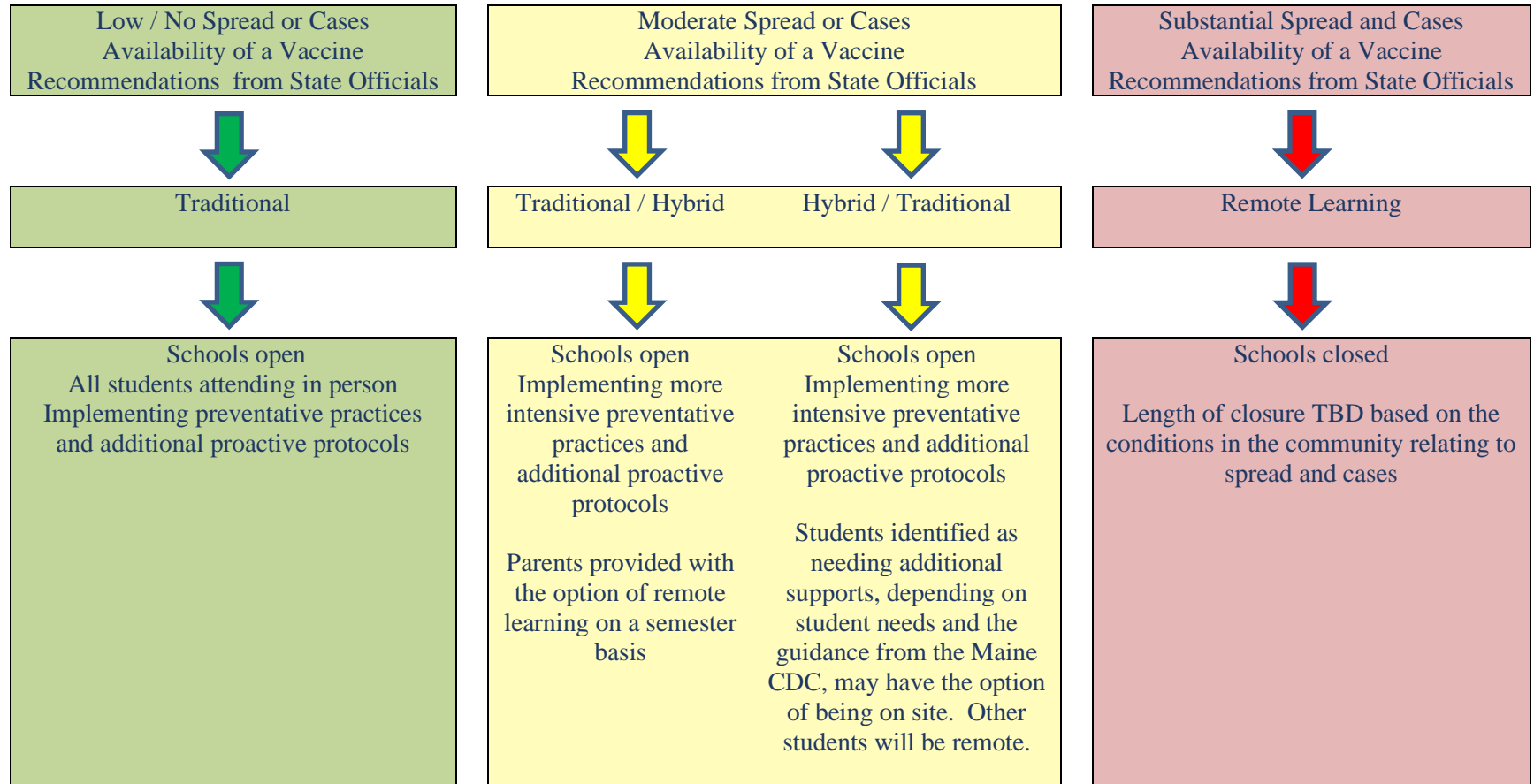

COVID-19 symptoms, preventative measures (including staying home when sick), good hygiene, and school/district specific protocols.</li> <li>• Clean/disinfect frequently touched surfaces regularly</li> <li>• Provide masks and other appropriate PPE to staff and require <del>wearing</del> <u>the use of PPE to the extent that it is mandated by the state.</u> <del>of face coverings unless taking an approved face covering break.</del></li> <li>• <del>The mask protocols and requirements may change based on recommendations and mandates from the state.</del></li> <li>• Take steps to ensure all water systems and features are safe</li> <li>• Ensure ventilation systems operate properly and increase circulation of outdoor air as much as possible, as long as this does not pose a safety or health risk to students or staff</li> <li>• Conduct <del>deep</del> cleaning of schools prior to students/staff returning each day; schedule periodic cleanings during <u>school breaks weekends or school holidays/breaks.</u> (to the extent practicable)</li> </ul>	<p><b>District/School Considerations:</b></p> <ul style="list-style-type: none"> <li>• Teach and reinforce good hygiene measures</li> <li>• Provide hand soap and hand sanitizer with at least 60% alcohol, paper towels, and <b>no-touch trash cans</b> in all bathrooms, classrooms, and frequently trafficked areas</li> <li>• Educate staff and students on strategies to curb the spread of COVID-19. COVID-19 symptoms, preventative measures (including staying home when sick), good hygiene, and school/district specific protocols</li> <li>• Clean/disinfect frequently touched surfaces at least daily and shared objects after each use</li> <li>• Provide masks and other appropriate PPE to staff and require wearing of face coverings unless taking an approved face covering break.</li> <li>• Allow students and staff to bring face coverings to use from home</li> <li>• Take steps to ensure all water systems and features are safe</li> <li>• Allow students and staff to bring water bottles from home and provide safe protocols for water fountain use</li> <li>• Ensure ventilation systems operate properly and increase circulation of outdoor air as much as possible, as long as this does not pose a safety or health risk to students or staff</li> <li>• Conduct cleaning of schools prior to students/staff returning each day; schedule additional cleanings when possible.</li> </ul>	<p><b>District/School Considerations:</b></p> <ul style="list-style-type: none"> <li>• Use district communication protocols to inform parents, students, and staff about COVID-19 symptoms, preventative measures, good hygiene, and school/district specific protocols</li> </ul>

<p><b>Transitioning</b></p> 	<p><b>District/School Considerations:</b></p> <ul style="list-style-type: none"> <li>• Conduct cleaning of <del>hallways and</del> high-touch surfaces <del>throughout the school day</del></li> <li>• <del>Designate areas of the hallway (i.e. lanes) to walk to keep students separated (to the extent practicable)</del></li> </ul>	<p><b>District/School Considerations:</b></p> <ul style="list-style-type: none"> <li>• Limit mixing between groups (to the extent practicable)</li> <li>• For class changes and other transitions throughout the school day: <ul style="list-style-type: none"> <li>○ Designate areas of the hallway (i.e. lanes) as flow paths to keep students separated students to minimize congregation of students</li> <li>○ Plan staggered class (ex: by hall, odd/even room numbers, grade/ discipline) changes to decrease number of students in hallways at one time</li> <li>○ <del>Have the same group of students stay with the same staff (all day for young children and as much as feasible for older children)</del></li> </ul> </li> </ul>	<p><b>School buildings are closed to students. Any exceptions must be approved by district administration.</b></p>

<p><b>Supporting Teaching and Learning</b></p> 	<p><b>District/School Considerations:</b></p> <ul style="list-style-type: none"> <li>• Provide hand sanitizer for students and staff</li> <li>• Conduct cleaning of classrooms and high touch surfaces each day</li> <li>• <del>Limit physical interaction through partner or group work</del></li> <li>• Develop a formative assessment calendar</li> <li>• <u>Utilize either Seesaw (pre k - grade 2) or Google Classroom (grades 3 -12) to facilitate any remote learning</u></li> <li>• Support the development of grade level academic topics</li> <li>• Provide additional instructional supports to: <ul style="list-style-type: none"> <li>○ students at-risk of not graduating on time</li> <li>○ students with disabilities</li> <li>○ students who struggled in the prior distance/remote learning environment</li> </ul> </li> </ul>	<p><b>District/School Considerations:</b></p> <ul style="list-style-type: none"> <li>• The Hybrid instructional model may be requested of families who prefer not to send their students to school in the traditional setting in certain circumstances.</li> <li>• Utilize either Seesaw (pre k - grade 2) or Google Classroom (grades 3 -12) to facilitate any remote learning</li> <li>• Balance class numbers as much as possible – remove unused desks and furniture in classrooms; maximize social distancing (to the extent practicable)</li> <li>• Limit physical interaction through partner or group work</li> <li>• Establish <u>a 6-foot appropriate</u> distance between the teacher’s desk/board and students’ desks</li> <li>• Identify and utilize large spaces (i.e. gymnasiums, auditoriums, outside spaces – as weather permits) for social distancing</li> </ul>	<p><b>District/School Considerations:</b></p> <ul style="list-style-type: none"> <li>• Implement a Distance Learning Plan</li> <li>• Utilize either Seesaw (pre k - grade 2) or Google Classroom (grades 3 - 12) to facilitate remote learning</li> <li>• Provide technology tools and support to families</li> </ul>

<p><b>When a Child, Staff Member, or Visitor Becomes Sick at School</b></p> 	<p><b>District/School Considerations:</b></p> <ul style="list-style-type: none"> <li>• Work with school administrators, school nurses, and other healthcare providers to identify <del>an isolation room or area</del> <u>a process</u> to separate anyone who exhibits COVID-like symptoms.</li> <li>• Notify local health officials of a possible case.</li> <li>• <del>Close off areas used by a person identified as testing positive for COVID-19 and do not use before cleaning and disinfection.</del></li> <li>• Inform those who have had close contact to a person diagnosed with COVID-19 to follow CDC guidance if symptoms develop</li> </ul> <p><del>Any student or staff member who is diagnosed by a physician to have tested positive for COVID-19 will be required to self-isolate for 10 days with at least 24-hours being symptom free</del> <u>follow the current CDC guidelines for isolation.</u></p>
